

**SIR ROBERT BLACK TRUST FUND**  
**Grants for Talented Students in Non-academic Fields 2021-22**  
**(Information Notes)**

The Sir Robert Black Trust Fund Committee (“the Committee”) now invites nominations from all primary and secondary schools in Hong Kong for Grants for Talented Students in Non-academic Fields 2021-22 (“the Grants”).

**The Award**

2. The Grants for Talented Students in Non-academic Fields were first introduced in 2006-07. It is a **non-renewable** award scheme which aims to encourage youth who might not be academically-oriented but are talented in either of the following areas for pursuing further studies in areas they excel :-

- (a) Visual arts and performing arts (including drama, dancing, etc.);
  - (b) Music (including composing, conducting, etc.);
  - (c) Design / innovations or inventions;
  - (d) Sports;
  - (e) Information technology;
  - (f) Media production / film art; and
  - (g) Others (e.g. public speaking, debate, cookery and embroidery, etc).
- \* Courses/trainings conducted by private tutors or applications for covering expenses related to participation in competitions or transportation fees for course/training will **not** be considered.

The Grants cover regular course/training fees only and any other expenses such as purchase of equipment, examination fees, administration fees, transaction fees, transportation fees, materials fees and annual fee, etc, are **not** eligible items.

**Selection Criteria**

3. A successful grantee is expected to be of good character with vision to contribute to Hong Kong. Selection of the grantees will be based on the following criteria –

- (a) Performance, potential and creativity of the students in the relevant non-academic field(s);
- (b) Circumstances of the family of the students; and
- (c) Recommendation of the schools.

## Nominations

4. Each school may nominate **up to 3 students** for the Grants with due regard to the criteria set out in 3(a) and 3(b) above.

## Nomination Form

5. Nominations should be submitted online **by schools** via <https://eform.one.gov.hk/form/hab008/en/>. Students and schools have to complete the relevant sections respectively in the online Nomination Form and upload the necessary supporting documents (if any). A printed copy of the online Nomination Form which are duly signed by the guardian and school principal with school chop, together with the documents submitted online, should be sent to the office of the Secretariat before the stipulated closing date (Please see Note 10).

## Completing the Form

6. Students should think thoroughly before deciding the courses/trainings they intend to enroll, the Committee would **not** consider any request for change of courses/trainings once the applications are submitted. Incomplete or faulty applications would affect the chance of selection and amount of grant adversely. Each student should only apply for **ONE** course/training and any application for more than one course/training would **not** be considered. All documents, including the Nomination Form, would not be returned once submitted and students are advised to make their own copies for future reference before submission.

## Selection of Grantees

7. All nominations will be vetted by the Committee for the purpose of selecting the successful grantees. Where necessary, the nominees may be required to attend interviews.

## Award of the Grants

8. The amount of each grant will normally not exceed HK\$5,000. In exceptional and deserving cases, the Committee may consider awarding grants of up to HK\$10,000 on case by case basis. Any application for **exceeding HK\$5,000 must be substantiated with a detailed statement from the Principal, in addition to Part B of the online Nomination Form, explaining why the Committee's special consideration is warranted and such statement should be uploaded when submitting the online application.** The Grants would be disbursed by means of reimbursement. Successful grantees are required to submit necessary documents via their schools upon completion of the courses/trainings. The list of the required documents will be provided by the Secretariat to the successful nominees in due course.

9. The Committee will only consider sponsoring courses/trainings which will take place **from February 2022 until January 2023**. For students who are in the graduating class in the academic year of 2021-22, i.e. Primary 6 / Senior Secondary 3 / Grade 12, the period should span **from February 2022 until July 2022** or the expected date of completion of courses/trainings (whichever is earlier), if they are selected. Except for courses/trainings of a continuous nature, those due for commencement prior to the formal announcement of the results of the captioned grant scheme will not be considered.

### **Deadline for Nominations**

10. The online Nomination Form will be closed for application by **5pm on 29 October 2021**. To complete the nomination, printed copy of the online Nomination Forms duly signed and stamped with school chops and **all documents as set out in Notes 5 and 8 (if any)** should be submitted **by schools** to the office of the Secretariat (34/F, Wu Chung House, 213 Queen's Road East, Wanchai, Hong Kong) **within 5 working days from the date of the online submission**. Otherwise, the nomination will be considered incomplete and will not be further processed. Schools making more than one nomination (no more than 3 nominations for each school) should submit all applications **at the same time**.

### **Announcement of Results**

11. Results of the Grants will be announced tentatively in **January 2022**.
