個人資料私隱政策聲明

民政及青年事務局（下稱「民青局」）尊重個人資料私隱，並致力遵行保障資料原則及全面實施《個人資料（私隱）條例》（《條例》）的所有相關規定。民青局承諾：

- 在當事人知情的情況下，以合法和公平的方法收集足夠（但不過量）的個人資料，而該等資料必須只為本局的職能或活動相關的合法目的而收集；
- 採取一切合理而切實可行的步驟，確保在顧及收集得來或保存的個人資料用於指定目的時這些個人資料是準確的，以及個人資料的保存時間不得超過將資料保存以使用於指定目的所需的時間；
- 把收集得來的個人資料，只用於在收集資料時所指定的目的或直接有關的目的，除非當事人已表明同意更改資料用途，或法律容許更改資料的用途；
- 採取一切合理可行的步驟，保障個人資料不受未獲准許的或意外的查閱、處理、刪除或其他使用所影響；
- 採取一切合理可行的步驟，確保公眾能獲告知本局的個人資料私隱政策及措施；以及
- 准許資料當事人查閱及更正個人資料，並以法律准許或規定的方式處理該等查閱/改正個人資料的要求。

Statement of Personal Data Privacy Policy

The Home and Youth Affairs Bureau (HYAB) respects personal data privacy and is committed to implementing and complying with the data protection principles and relevant provisions under the Personal Data (Privacy) Ordinance (PDPO). HYAB undertakes to –

- collect adequate, but not excessive, personal data by lawful and fair means only for lawful purposes related to HYAB's functions or activities and for which, data subjects shall be informed;
- take all reasonably practicable steps to ensure that the personal data collected or retained are accurate, and that the personal data are not kept longer than is necessary for the purposes for which they are to be used;
- use the personal data collected only for purposes or directly related purposes for which the data were to be used at the time of collection, unless the data subject concerned has given express consent for a change of use or such use is permitted by law;
- take all reasonably practicable steps to ensure that personal data are protected against unauthorised or accidental access, processing, erasure, loss or other use;
- take all reasonably practicable steps to ensure that the public is informed of HYAB's policy and practices in relation to personal data; and
- permit data subjects to access and correct their personal data and process any such access / correction requests in a manner permitted or required by law.
